- This quotation assumes that the electrical power supply and/or water supply for any of the Essential Fire Safety Measures are capable of being isolated.
- If at any time, additional works are required that are outside the scope of the quotation, a variation will be raised. This variation has to be approved in writing before any additional work can be carried out.
- Exclusions:
  - Works outside normal working hours (7.00am – 3.30pm Monday – Friday).

- Any costs arising from the presence of asbestos, synthetic fibres or any other like substances. Any such costs will be subject to additional charges.
  - We accept no responsibility for the efficiency, structural or hydraulic adequacy of any onsite drainage or pipe-work during any testing or repair.
  - Parts and labour to repair damages caused by vandalism and electrical surges, negligence by other, misuse, floods, acts of God / force majeure.
  - Locating of pipes, cables and any Essential Fire Safety Measure hidden by building works.
  - Any electrical works will rely upon utilising the existing power supply only
  - Patching, painting and making good unless specifically nominated
  - During any drilling or excavation into walls, floors or ceilings, we take no responsibility for any services (water, gas power etc.) hidden or located therein for the duration of the works unless we are provided with detailed plans showing the precise location of these services.
6. This quotation has allowed for continuous, uninterrupted access to all fire safety measures on the same day for the above repairs. If access is not available during the agreed times, then additional cost will apply to gain access @ \$90.00 + GST/hr per person per additional visit plus travel (\$100.00 + GST per visit per person).
7. Our terms of payment are strictly 14 days from date of invoice. All goods and materials supplied/installed shall remain the property of Complete Fire Certification until payment has been received in full. We reserve the right to recover any such goods/materials at any time should payment not be made in accordance with our terms.
